COUNCIL ON AGING'S (COA) HOME AND COMMUNITY-BASED SERVICES MAKE IT POSSIBLE FOR FRAIL OLDER ADULTS AND INDIVIDUALS WITH DISABILITIES TO REMAIN INDEPENDENT IN THEIR HOMES AND AVOID UNNECESSARY HOSPITALIZATION AND NURSING HOME PLACEMENT. SERVICES ALSO SUPPORT FAMILY CAREGIVERS WHO ARE STRUGGLING TO BALANCE COMPETING RESPONSIBILITIES INCLUDING CHILDREARING AND CAREERS. COUNCIL ON AGING'S CORE SERVICE AREA INCLUDES BUTLER, CLERMONT, CLINTON, HAMILTON AND WARREN COUNTIES.

IN-HOME CARE IS PREFERRED BY MORE THAN 90 PERCENT OF OLDER ADULTS, ACCORDING TO SURVEYS BY AARP AND OTHER ORGANIZATIONS. IN ADDITION, THE COST FOR IN-HOME CARE IS A FRACTION OF THE COST OF CARE IN A NURSING HOME. BECAUSE TAXPAYERS FUND MOST NURSING HOME CARE (VIA MEDICAID), IN-HOME (SEE ON SCHEDULE O)

THE CARE MANAGER'S ROLE IS TO ENSURE INDIVIDUALS RECEIVE THE RIGHT SERVICES, IN THE RIGHT AMOUNTS, AT THE RIGHT TIMES.

IN FFY 2025, COUNCIL ON AGING SERVED 27,358 INDIVIDUALS IN OUR MULTI-COUNTY REGION WITH HOME AND COMMUNITY-BASED SERVICES. INDIVIDUALS WERE SERVED THROUGH A VARIETY OF PROGRAMS, INCLUDING OHIO MEDICAID WAIVER PROGRAMS AND COUNTY TAX LEVY PROGRAMS, AS WELL AS PROGRAMS DESIGNED TO HELP INDIVIDUALS SAFELY TRANSITION FROM HOSPITALS AND INSTITUTIONS, BACK TO INDEPENDENT LIVING ENVIRONMENTS. COLLECTIVELY, THESE INDIVIDUALS RECEIVED MORE THAN 1.6 MILLION HOURS OF IN-HOME, SUPPORTIVE SERVICES.
