

# Awards, Grants and Recognition

## 2024

**NCOA Benefits (NCOA) Benefits Enrollment Center Grant** – Council on Aging received an NCOA Benefits Enrollment Center Grant to support the organization in becoming a Benefits Enrollment Center (BEC). The goal of the BEC program is to promote lasting transformations to the ways older adults and adults living with disabilities are assisted with enrolling in and retaining the benefits they are eligible for. BECs use person-centered strategies in a coordinated, community-wide approach to find and enroll Medicare beneficiaries who have limited income and resources to access available benefits.

**2024 Cincinnati Business Courier C-Suite Award** – Vice President of People Services Jacqueline Hutsell was named a 2024 *Cincinnati Business Courier* C-Suite Award Honoree. The C-Suite Awards recognize top-level executives whose leadership skills and business acumen have driven strong results for organizations across Greater Cincinnati.

**McCullough Hyde Foundation Grant** – The McCullough-Hyde Foundation awarded COA a \$10,000 grant to support its FastTrack Home program in Butler County. FastTrack Home provides in-home care services such as homemaking, home-delivered meals and medical transportation to older adults when they need them most – as they are leaving the hospital or nursing home. The foundation's Community Granting Program is a philanthropic program that makes investments that address significant health needs of local communities.

**Ohio Department of Aging Opioid Education Grant** – The Ohio Department of Aging awarded a \$33,000 grant to Council on Aging to provide education about opioid use and misuse in older adults. Using the grant dollars, COA planned and executed a professional development conference that provided free continuing education units for Ohio social workers and nurses. The conference featured local experts on opioid and addiction issues and attracted more than 140 attendees. Additionally, COA launched a public education campaign in its region using print and digital media to reach approximately 340,000 individuals. [Read More](#)

**Duke Energy Foundation Grant** – During its 40<sup>th</sup> anniversary year, the Duke Energy Foundation awarded a \$10,000 grant to COA. The grant dollars support a new partnership between COA and the New Life Furniture Bank intended to furnish the homes of approximately 25 COA clients in need.

**Ohio Kentucky Indiana Section 5310 Funding for home52 Transportation** – Council on Aging and its subsidiary home52 received federal funding to improve mobility for older adults and individuals with disabilities by removing barriers to transportation services and expanding transportation options. The funding supports home52 Transportation, which manages multiple transportation providers through a centralized transportation coordination system, providing specialized, on-demand and advance-scheduled trips for older adults and people with disabilities.

**WeThrive HCPH Mini Grant II** – Council on Aging received a \$160,000 WeThrive Hamilton County Public Health (HCPH) Mini Grant II to expand access to COA’s evidence-based wellness education programs for older adults within the HCPH jurisdiction. The grant supports efforts to reduce social isolation, improve chronic disease management and enhance access to preventive health education. With this funding, COA offers transportation assistance to older adults participating in wellness workshops within WeThrive communities, ensuring they can access critical programs without mobility barriers. The grant also strengthens partnerships with local community host sites, increasing opportunities for older adults to engage in wellness education.

**USAgings Center of Excellence to Align Health and Social Care (COE) Grant** – Council on Aging and Direction Home Akron Canton Area Agency on Aging & Disabilities received a COE grant. The COE, funded by the U.S. Administration for Community Living, aims to strengthen community care hubs by integrating health-related social needs assessments, improving care management systems and ensuring efficient data sharing between healthcare and social service networks.

**Inform USA 2024 Innovation Award** – COA is honored to partner with Hamilton County on its innovative 513Relief Bus. Along with other social services agency reps, a COA specialist is aboard the bus at many of its stops in the community, sharing information about programs and services for older adults and caregivers. In 2024, this cooperative relationship was recognized by [Inform USA](#) with a 2024 Innovation Award in the Collaboration category. The award recognizes the innovative opportunity the 513Relief Bus provides COA and other partners in bringing services and resources directly to the people of Hamilton County. [Read More](#)

**Discretionary Grants** – COA received three discretionary grants from Interact for Health, GRAIL Bioscience and PhRMA, which are supporting its efforts to preserve and enhance service offerings, implement health and wellness programs and increase community awareness of programs and services that promote dignity, choice and independence for older adults and caregivers in its region.

## 2023

**USAgings Vaccination Grant** – In 2023, Council on Aging received funding from the USAging-led Aging and Disability Vaccination Collaborative (ADVC) to conduct activities aimed at connecting older adults and people with disabilities to COVID-19 and flu vaccines. Led by USAging and funded by the U.S. Administration for Community Living, the ADVC grants help communities stay healthy by targeting older adults and people with disabilities, particularly those from historically marginalized and underserved communities in which vaccination rates are low. **Cigna Foundation Health and Wellbeing Grant** – Council on Aging received a Cigna Foundation Health and Wellbeing Grant to support older adults who are socially isolated by providing opportunities for social connectedness through both virtual and in-person activities. The grant provided home52 Transportation services to medical and non-medical appointments; connections to local senior centers; Animal Companion Counseling; access to virtual programming for older adults; and connections to Meals on Wheels programming.

**Federal Transit Administration 5310 Funding** – Council on Aging and its subsidiary home52 received federal funding to improve mobility for older adults and individuals with disabilities by removing barriers to transportation services and expanding transportation options. The funding supports home52 Transportation, which manages multiple transportation providers through a centralized transportation coordination system, providing specialized, on-demand and advance-scheduled trips for older adults and people with disabilities. **dmi:Design Value Award** – In October, Council Aging and its partner, the Live Well Collaborative, received a first place 2023 dmi:Design Value Award from the Design Management Institute (DMI). The award acknowledges organizations that have made significant contributions to the field of design and have demonstrated a commitment to improving people's lives through design excellence. COA and Live Well received the award for work on a project that sought to redesign the way meal programs are delivered to older adults through select Council on Aging programs. [Read More](#)

USAging annually identifies and showcases members' innovative and successful programs to encourage their replication by other agencies. This national award honors long-term care case managers for their outstanding achievements in the areas of nutrition, health and healthy lifestyles. **HUDs Older Adults Home Modification Program** – In April, Council on Aging was awarded a \$1.25 million grant from the U.S. Department of Housing and Urban Development’s (HUD) Older Adults Home Modification Program. The program aims to enable low-income older adults to remain in their homes through low-cost, low barrier, high impact home modifications to reduce their risk of falling, improve general safety, increase accessibility, and improve their functional abilities in their home. **2023 AARP Community Challenge Grant** – In June, home52 Transportation, a service of Council on Aging (COA) subsidiary home52, received a 2023 AARP Community Challenge Grant. home52 Transportation was one of only 310 grantees nationwide (out of 3,600+ applications). The \$35,168 grant was in the Transportation Systems Change Demonstration category, which is supported by Toyota Motor North America. The AARP grant provided funding for the development of educational tools to help older riders access and use an online scheduling platform, including step-by-step videos and printed guides, as well as in-person education sessions for those who require additional assistance. **Community Care Hub National Learning Community** – Council on Aging was one of 58 organizations selected by the U.S. Administration on Community Living (ACL) and the Centers for Disease Control and Prevention (CDC) to participate in this collaborative focused on addressing health-related social needs and public health needs through contracts with health care entities. **Interact for Health Advised Grant** – In August, Council on Aging received a \$6,500 Interact for Health Advised Grant. The funds will play a critical role in meeting the transportation needs of low-income older adults who do not qualify for other existing transportation programs.

**City of Cincinnati Human Service Fund supports home52 Transportation** – home52 Transportation received \$55,000 from the City of Cincinnati Human Service Fund to coordinate free non-emergency medical transportation for low income older adults. home52, a wholly owned subsidiary of Council on Aging, will partner with low-income senior housing units in the City of Cincinnati to coordinate transportation for residents with barriers to appropriate transportation to meet their medical needs.

## 2020

**Association of Professionals in Aging 2020 Hero Award** – In December, COA and several other area service providers, were recognized as Heroes for their response efforts related to the COVID-19 pandemic.

**bi3 Grant** – In November, bi3, Bethesda Inc.'s grantmaking initiative, awarded \$50,000 to Council on Aging (COA) to help support the implementation of virtual case management and assessment visits. bi3 sought proposals addressing health or social needs that impact health outcomes, particularly for people experiencing health disparities. The \$50,000 grant award will help build COA's care management capacity, strengthen operations and better position the organization to meet future needs. [Read More](#)

**Humana Bold Goal Grant** – In November, COA received a \$25,000 grant from Humana as part of its Bold Goal population health strategy to improve the health of the communities it serves. The grant helped COA sustain its award-winning COVID-19 comfort meal program, which provided more than 47,000 restaurant meals to low-income older adults in COA's service area during the COVID-19 pandemic. The awards, created in 2020 by the Wilmington-Clinton County Chamber of Commerce, along with the Clinton County Convention and Visitors Bureau, highlight stories of the Clinton County citizens, employers and employees, and organizations making an impact in the community during the COVID-19 pandemic.

COA was recognized in the nonprofit category for its Comfort Meal Program. The program is a COA partnership with local restaurants that delivers meals to low-income older adults to help them combat monotony and isolation during the pandemic. In addition, COA nominee and Clinton County resident Donna Slone-Gumbert received a C4 award in the citizen category.

Donna was selected as a winner for her work as a key partner in serving older adults in Clinton County – delivering food and essential supplies to those in need. [Read More](#)

**Outstanding AAA Partnership of the Year Award** – In October, COA received the Ohio Association of Area Agencies on Aging (o4a) 2020 Outstanding AAA Partnership of the Year award for its Comfort Meal Program. Through COA's partnerships with nine local restaurants, about 50,000 meals were delivered to the doorsteps of low-income older adults during 2020. The program also helped its partner restaurants continue to operate during a time of shut-downs and limits on dine-in service.

**Aetna Grant** – In April, COA received a \$40,000 grant from Aetna, a CVS Health business (Aetna), supporting its response to the COVID-19 outbreak. The grant was part of more than \$1 million CVS Health



and its foundations gave to address food insecurity and other community needs in response to the challenges presented by pandemic. [Read More](#)

Named the "Care Census," COA collected data from employees in our region that demonstrates to businesses how changing demographics and gaps in our country's long-term care system impact their employees.

**COA Awarded Federal Transportation Grant** – In May, received a \$470,000 grant from the Federal Transit Administration (FTA). The award was part of FTA's Access and Mobility Partnership Grants which awarded approximately \$9.6 million to 37 projects led by transit agencies, governmental authorities and nonprofit organizations to support innovative transportation solutions to expand access to health care. Council on Aging used the funding to design and implement a centralized, on-demand transportation service to coordinate non-emergency medical transportation for older adults in COA's service area.
